HB 2009

(POLLOCK)
LEGISLATIVE OVERSIGHT
FOR SCHOOL VACCINE
MANDATES



URGENT

STATUS: HB 2009 MUST get to the House floor ASAP! This is urgent! Read more [here](#).

ACTION: COME TO THE CAPITOL IN PERSON TODAY and TOMORROW!! Or call/email to get more Reps to co-sponsor HB 2009. Also urge Floor Leader Plocher to bring it to the House floor. **THIS IS CRITICAL!** More info: ihcm.info/ . Scroll down to HB 2009.

STATUS: Like HB 2009, HB 1616 must get to the House floor ASAP in order for it to have a chance of passing both houses.

ACTION: CALL YOUR REP AND ASK HIM/HER TO CO-SPONSOR HB1616. Also ask them to urge Floor Leader Plocher to bring it to the House floor. You can also get more information on this bill at ihcm.info/. Scroll down to HB 1616 Certificate of Need.

HB 1692

(BOGGS)
MAKES EMPLOYERS LIABLE
FOR VACCINE INJURIES



STATUS: Like previous bills, HB 1692 must get to the House floor ASAP in order to survive. We need to get as many Reps to co-sponsor as possible and urge Floor Leader Plocher to get this to the House floor.

ACTION: CALL or EMAIL YOUR REP. Find them [here](#). Ask him or her to CO-SPONSOR HB 1692 and ask them to support it when it comes to the House floor.

STATUS: HB 1686 is farther along than any other bill on our list. It has passed the House and has been through a hearing in the Senate. It would protect government employees from vax mandates and require employers to allow religious exemptions.

ACTION: CALL or EMAIL YOUR SENATOR. Find them [here](#). Ask them them to:
1- Urge Sen. Pro Tem Dave Schatz to call HB 1686 out of committee.
2- Vote YES when it comes to the floor.

SCS SB'S 727 & 890

(ONDER/MOON)
REPEAL CERTIFICATE OF
NEED LAW



STATUS: SB 890 has been combined with Sen. Onder's SB 727. This committee substitute has been through a hearing. We need to urge Senator Schatz to CALL IT OUT OF COMMITTEE and to the Senate floor **ASAP**.

ACTION: CALL or EMAIL YOUR SENATOR. Find them [here](#). Ask them them to:
1- Urge Sen. Pro Tem Dave Schatz to CALL SCS SB's 727 & 890 (Certificate of Need bills) OUT OF COMMITTEE.
2- Vote YES when this bill comes to the floor.
