SB 727

(ONDER/MOON SENATE COMMITTEE SUBSTITUTE) REPEAL CERTIFICATE OF NEED LAW STATUS: Senator Moon's SB 890 has been merged with Sen. Onder's SB 727 CON bill. We need Speaker Pro Tem, Dave Schatz, to call this out of committee immediately!

ACTION: CALL or EMAIL YOUR SENATOR (click here) and ask him/her to:

1- Urge Sen. Pro Tem, <u>Dave Schatz</u>, toCALL SB 727 OUT OF COMMITTEE.2- Vote YES when this bill comes to the Senate floor.

STATUS: HB 1686 is added to our list because it has the best chance of passing both houses. HB 1686 does some good things. It would protect government employees from vax mandates and require employers to allow religious exemptions.
